I. INTRODUCTION

A. RISK FACTORS

■ Standard Risk Factors

- Investment in Mutual Fund Units involves investment risks such as trading volumes, settlement risk, liquidity risk, default risk including the possible loss of principal.
- As the price / value / interest rates of the securities in which the Scheme invests fluctuates, the value of your investment in the Scheme may go up or down depending on the various factors and forces affecting the capital markets and money markets.
- Past performance of the Sponsors and their affiliates / AMC / Mutual Fund does not guarantee future performance of the Scheme(s) of the Mutual Fund.
- The name of the Scheme does not in any manner indicate either the quality of the Scheme or its future prospects and returns.
- The Sponsors are not responsible or liable for any loss resulting from the operation of the Scheme beyond the initial contribution of ₹1 lakh each made by them towards setting up the Fund.
- The present Scheme is not a guaranteed or assured return scheme.

■ Scheme Specific Risk Factors

Some of the specific risk factors related to the Scheme include, but are not limited to the following:

Risk factors associated with Capital Protection Orientation

- The scheme is "oriented towards protection of capital" and "not with guaranteed returns". The scheme does not guarantee any returns. The orientation towards protection of capital originates from the structure of the Portfolio of the Scheme and not from any Bank guarantee, Insurance Cover etc. There is no assurance that the structure would provide the necessary protection of capital.
- Factors such as interest rate movements, reinvestment risk, credit defaults etc. can impact the ability of the portfolio to meet capital protection on maturity.
- All CRISIL ratings are under surveillance. CRISIL reserves the right to suspend, withdraw or revise its ratings at any time on the basis of any new information or unavailability of information or any other circumstances which CRISIL believes may have an impact on the rating.
- The initial investment mix of the scheme is based upon assumptions on collections, pre-determined initial and running expenses and yield on the securities in the fixed income portfolio.
- The scheme could face reinvestment risks on interim interest cash flows, if the yield on such reinvestments is lower than the yield on the initial investments.

Risk factors associated with investing in Fixed Income Securities

- Trading volumes, settlement periods and transfer procedures may restrict the liquidity of the investments made by the Scheme. Different segments of the Indian financial markets have different settlement periods and such periods may be extended significantly by unforeseen circumstances leading

to delays in receipt of proceeds from sale of securities. The NAV of the Scheme can go up or down because of various factors that affect the capital markets in general.

- The NAV of the Scheme will be affected by changes in the general level of interest rates. The NAV of the Scheme is expected to increase from a fall in interest rates while it would be adversely affected by an increase in the level of interest rates.
- Money market securities, while fairly liquid, lack a well developed secondary market, which may restrict the selling ability of the Scheme and may lead to the Scheme incurring losses till the security is finally sold.
- Investment in Debt Securities is subject to the risk of an issuer's inability to meet interest and principal payments on its obligations and market perception of the creditworthiness of the issuer.
- Government securities where a fixed return is offered run price-risk like any other fixed income security. Generally, when interest rates rise, prices of fixed income securities fall and when interest rates drop, the prices increase. The extent of fall or rise in the prices is a function of the existing coupon, days to maturity and the increase or decrease in the level of interest rates. The new level of interest rate is determined by the rates at which government raises new money and/or the price levels at which the market is already dealing in existing securities. The price-risk is not unique to Government Securities. It exists for all fixed income securities. However, Government Securities are unique in the sense that their credit risk generally remains zero. Therefore, their prices are influenced only by movement in interest rates in the financial system.
- Different types of fixed income securities in which the Scheme would invest as given in the Scheme Information Document carry different levels and types of risk. Accordingly, the Scheme risk may increase or decrease depending upon its investment pattern. e.g. corporate bonds carry a higher level of risk than Government securities.
- As zero coupon securities do not provide periodic interest payments to the holder of the security, these securities are more sensitive to changes in interest rates. Therefore, the interest rate risk of zero coupon securities is higher. The AMC may choose to invest in zero coupon securities that offer attractive yields. This may increase the risk of the portfolio.
- While securities that are listed on the stock exchange carry lower liquidity risk, the ability to sell these investments is limited by the overall trading volume on the stock exchanges and may lead to the Scheme incurring losses till the security is finally sold.
- Securities, which are not quoted on the stock exchanges, are inherently illiquid in nature and carry a larger amount of liquidity risk, in comparison to securities that are listed on the exchanges or offer other exit options to the investor, including a put option.
- At times, due to the forces and factors affecting the capital market, the Scheme may not be able to invest in securities falling within its investment objective resulting in holding the monies collected by it in cash or cash equivalent or invest the same in other permissible securities amounting to substantial reduction in the earning capability of the Scheme.

Risk Factors associated with Market Trading

- Although Units of the Scheme as mentioned in this Scheme Information Document are to be listed on the Exchange, there can be no assurance that an active secondary market will develop or be maintained.
- Trading in Units of the Scheme on the Exchange may be halted because of market conditions or for reasons that in view of Exchange Authorities or SEBI, trading in Units of the Scheme is not advisable. In addition, trading in Units of the Scheme is subject to trading halts caused by extraordinary market volatility and pursuant to Exchange and SEBI 'circuit filter' rules. There can be no assurance that the requirements of Exchange necessary to maintain the listing of Units of the Scheme will continue to be met or will remain unchanged.
- Any changes in trading regulations by the Stock Exchange(s) or SEBI may inter-alia result in wider premium/ discount to NAV.
- The Units of the Scheme may trade above or below their NAV. The NAV of the Scheme will fluctuate with changes in the market value of Scheme's holdings. The trading prices of Units of the Scheme will fluctuate in accordance with changes in their NAV as well as market supply and demand for the Units of the Scheme.
- The records of the depository are final with respect to the number of Units available to the credit of Unit holder for the Units issued in dematerialised form. Settlement of trades, repurchase of Units by the Mutual Fund on the maturity date / final redemption date will depend upon the confirmations to be received from depository(ies) on which the Mutual Fund has no control.
- The market price of the Units of the Scheme, like any other listed security, is largely dependent on two factors, viz., (1) the intrinsic value of the Unit (or NAV), and (2) demand and supply of Units in the market. Sizeable demand or supply of the Units in the Exchange may lead to market price of the Units to quote at premium or discount to NAV.
- As the Units of the Scheme will be listed on the Exchange, the Mutual Fund shall not provide for redemption / repurchase of Units prior to maturity / final redemption date of the Scheme.

B. REQUIREMENT OF MINIMUM INVESTORS IN THE SCHEME

The Scheme shall have a minimum of 20 investors and no single investor shall account for more than 25% of the corpus of the Scheme. These conditions will be complied with immediately after the close of the NFO itself i.e. at the time of allotment. In case of non-fulfillment with the condition of minimum 20 investors, the Option shall be wound up in accordance with Regulation 39 (2) (c) of SEBI (MF) Regulations automatically without any reference from SEBI. In case of non-fulfillment with the condition of 25% holding by a single investor on the date of allotment, the application to the extent of exposure in excess of the stipulated 25% limit would be liable to be rejected and the allotment would be effective only to the extent of 25% of the corpus collected. Consequently, such exposure over 25% limits will lead to refund within 5 business days from the date of closure of the New Fund Offer.

- The Trustee, AMC, Mutual Fund, their directors or their employees shall not be liable for any of the tax consequences

F. INDIAN CANCER SOCIETY (ICS)- A BRIEF PROFILE

The vision of two great men, Dr. D. J. Jussawala and Mr. Naval Tata led to the birth of the Indian Cancer Society (ICS), the National Anti-Cancer Association of India in 1951. Their mission was two fold, to expand upon the cancer therapies available in India and to help and rehabilitate India's poor and underprivileged cancer patients.

In its existence for nearly six decades, ICS has been in the forefront of rehabilitation and welfare of the poorest of the poor suffering from cancer, by providing them with emotional, physical and financial support.

ICS undertakes total care of the poor cancer patients by offering food, medicines, transport, prostheses, colostomy bags, counseling services, social welfare and job placement services. It also helps cancer patients to be self- employed particularly those who come from the rural areas.

ICS represents India at the General Assembly of the International Cancer Union (Based in Geneva).

ICS is registered as a Public Trust under the Societies Registration Act, 1860 and the Bombay Public Trust Act, 1950 and is recognized premier national agency very actively involved in the crusade against cancer for more than 58 years as a charitable and non- profit making Institution.

VISION

To be the beacon of hope in India's fight against cancer, by providing affordable and innovative solutions, for the detection and treatment of cancer, and for the post treatment rehabilitation of its survivors.

MISSION

To investigate, research and record its incidence, prevalence, causes and pathology and to facilitate treatment, cure and palliative care of cancer patients.

Establish cancer survivorship programs to help provide emotional, physical and financial support, post treatment, especially for the poor.

Establish Special Home Care Centres on its own or in collaboration, for children and adults affected by cancer and to assist in the formation of support groups.

To do so with compassion and consummate care and by setting the highest standards of safety and hygiene.

And finally to erase the fear of cancer by promoting it as a treatable disease.

Activities

The Main activities that are carried out by ICS are:

- Rehabilitation of underprivileged cancer survivors by providing them vocational training and jobs at the ICS Rehabilitation Centre at Parel, Mumbai.
- Conducting cancer prevention and awareness programs and its clinics and mobile detection camps in Maharashtra, Gujarat, Goa, Delhi and U.P., which encourage the public to avail of affordable cancer detection screening at nil or just 10% of the normal cost.
- Maintenance of the ICS Cancer Registry for Maharashtra
- Dwelling units for 50 child cancer patients along with their parents, completely free of cost, at the Rehabilitation Centres at Mumbai and Delhi.

- Providing financial assistance to the underprivileged for cancer treatment.
- Undertake programmes and projects to educate the public about the factors relevant to cancer and conduct continuing educational courses for doctors.
- Food and Nutritional Supplements are offered to poor cancer patients daily (worth nearly ₹ 12 lakhs per year)

Achievements

- i. ICS established the first Rehabilitation Centre at Parel, Mumbai in 1961 which is the largest of its kind in Asia and also established the Indian Association of Oncologists (the first professional Society of Indian Cancer specialists) in 1977.
- ii. In 1963, ICS established the oldest Cancer Registry for Mumbai, which was later extended to the whole of Maharashtra. They have proved of great help to our Government and the World Health Organization (WHO), to assess the incidence and mortality of cancer in India.
- iii. ICS's research programme includes publication of the internationally recognized "Indian Journal of Cancer". It has also published a Hand Book for doctors, on the Diagnosis and Management of Cancer, through Longmans, the International publishers.
- iv. ICS was instrumental in establishing the first Chemotherapy Department and first Cytology Laboratory in India at the Tata Memorial Hospital.
- v. Sponsored three Patient-Oriented National Organizations in our country - The Ostomy Association of India, The Indian Association of Laryngectomees and The Reach for Recovery Programme (for women who have undergone breast surgery for cancer).

Projects

Some of the major projects currently handled by ICS are:

- Renovation of Rehabilitation Research Centre at Parel, Mumbai and setting up of similar units in Delhi, Kolkatta and Chennai in the near future.
- Extension of Cancer Detection Programme by adding a Mammography Van
- Creating a mega Cancer Treatment Fund to help poor patients.

Funding

ICS presently has an all India expense budget of approx ₹ 4.50 crore per year, of which about ₹ 2 crore is the revenue gap that is funded through donations and various fund mobilisation measures. Medical relief for poor patients accounts for only ₹ 15 lacs or so of this annual budget due to paucity of funds. Hence, the need for a dedicated mega fund for enabling medical treatment of such patients.

Locations

ICS has seven branches in Mumbai, New Delhi, Kolkatta, Bengaluru, Lucknow, Patna and Nagpur. In addition it has 25 affiliate hospitals and NGOs spread across the following cities: Manipal, Silchar, Jaipur, Surat, Nashik, Thane, Pune, Ahmednagar, Ludhiana, Miraj, Bhubhaneshwar, Satara and Kolhapur.

1. Approve guidelines for utilization and disbursement of funds
2. Approve financial assistance to applicants based on above guidelines.
3. Appoint auditors for audit of the Fund and its utilization.
4. Conduct periodic reviews of the cases approved for cancer treatment aid

GAC may comprise of following eminent members:

- **Nihal Kaviratne** (Chairman of GAC) : His global career at Unilever spanned over 40 years during which he held several key leadership positions including Chairman & CEO Unilever Indonesia, Chairman of Unilever's US\$ 2.5 billion Home and Oral Care business in Asia. He completed his work with Unilever in December 2005. He serves as an independent director on several boards of companies and is the founder of St. Jude India Child Care Centres. He is also the Chairman of Indian Cancer Society.
- **Keki Dadiseth**: A Fellow of the Institute of Chartered Accountants of England & Wales, Keki Dadiseth joined Hindustan Lever Limited in India in 1973 and became its Chairman in 1996. Keki was appointed Director on the Board of Unilever plc and Unilever NV in May 2000 and a Member of the Executive Committee. On January 1, 2001, he took over as Director, Home and Personal Care, responsible for the HPC business of Unilever worldwide. He retired from Unilever in May 2005.
- **Homi Khusrookhan**: He worked for 29 years with Glaxo & Burroughs Wellcome in India and retired in 2000 as Managing Director of both companies. After retiring from Glaxo in December 2000, he joined the Tata Group as MD of Tata Tea Ltd. and then moved into Tata Chemicals Ltd in 2004. He retired as MD of Tata Chemicals in December 2008.

- **Ajit Nimbalkar**: He served in the IAS for 37 years and held several positions at the District, State and Central levels during different periods. He retired as Chief Secretary, Maharashtra on 31st May 2004. Subsequently, he was appointed as Adviser to the State Government from June 2004 to March 2005. From August 17,2005, he is working as Chairman, Maharashtra Water Resources Regulatory Authority (MWRRA).
- **M.K.Sharma**: He joined Hindustan Lever Limited in 1974 as Legal Manager and worked in various areas including taxation, shares and legal. He was inducted on the Board of Hindustan Lever Limited in August 1995. He retired as the Vice-Chairman of Hindustan Unilever Limited in May 2007. He is also on the Board of ICICI Bank since January 2003.
- **Dr. Rustom Soonawala**: He is a leading Gynecologist affiliated with Breach Candy Hospital and Jaslok Hospital, among others.
- **Dr. Rajendra Badwe**: He is the Director of Tata Memorial Centre and a Professor and the Head of Department of Surgical Oncology, Tata Memorial Hospital.
- **Dr. Anita Borges**: She is a renowned surgical pathologist and is currently Professor of Pathology and In Charge of Surgical Pathology at the Tata Memorial Hospital, Mumbai.
- **Smita Aggarwal** (Member Secretary to the GAC) She is a Chartered Accountant with over 18 years of experience in banking and financial services.

HDFC AMC shall also have a right to nominate one person as a member of GAC and such nominee shall not have any fiduciary responsibility to ICS nor to any third party. HDFC AMC or the nominee of HDFC AMC as a member of GAC will not be responsible for the functioning of the GAC or the day or day administration of the utilization of the funds received from the Unit holders of the Scheme.

In addition the following would be a permanent invitee to the GAC

- **Dr. Arun Kurkure**: He is a leading surgical oncologist affiliated with Breach Candy Hospital and Saifee Hospital, Mumbai. He is also the Managing Trustee of Indian Cancer Society and Chairman of the team directly responsible for the due diligence process of identifying and recommending patients for financial aid.

All donations received by ICS from HDFC Debt Fund for Cancer Cure Unit holders would be credited to a separate bank account and the utilization of these proceeds for the purpose stated above would be audited each year by an independent auditor.

Donation made by Unit holders would be entitled to exemption under Section 80G of the Income-tax Act, 1961.

RATIONALE FOR LAUNCH OF THE SCHEME

The genesis of the idea of launching HDFC Debt Fund for Cancer Cure in association with Indian Cancer Society is to provide financial assistance to the needy cancer patients for their treatment by tapping those investors who would be willing to donate part of the dividend or entire dividend declared, if any, under the Scheme for this purpose.

The money raised through donation of dividend income by Unit holders of "HDFC Debt Fund for Cancer Cure" would be utilized by ICS for the following purpose:

- Fund the treatment costs of needy and under-privileged cancer patients in established hospitals.
- Provide medically recommended food and nutritional support to the cancer patients undergoing treatment.
- Meet direct expenses of carrying out the above activities, limited to 5% of the total donations.

Providing financial aid for cancer treatment is the most critical need of the underprivileged part of the society, which ICS currently strives to fulfill in a limited way. There are approximately 400 cancer patients every year that come to ICS, Mumbai alone for financial assistance for their treatment, which on an average would cost them ₹ 2 lacs each. ICS presently with its limited resources, is able to fund only ₹ 5000 - 10,000 to each of these patients. These patients, therefore, go from door to door trying to collect the balance funds. Their efforts are seldom successful and as a result, their continuous treatment and survival becomes extremely difficult. The donation received from Unit holders would directly go to fund the treatment cost of a cancer patient and thereby provide a new hope and life to an individual suffering from this disease.

II. INFORMATION ABOUT THE SCHEME

A. TYPE OF THE SCHEME:

The Scheme is a 3 year Closed-ended Capital Protection Oriented Income scheme.

B. WHAT IS THE INVESTMENT OBJECTIVE OF THE SCHEME?

The objective of the Scheme is to protect the capital and generate income through investments in high quality fixed income securities like Debt / Money Market Instruments and Government Securities maturing on or before the maturity date of the Scheme.

However, there can be no assurance that the investment objective of the scheme will be realized.

C. HOW WILL THE SCHEME ALLOCATE ITS ASSETS? ASSET ALLOCATION:

In addition to the instruments stated in the table above, the Scheme may enter into repos/reverse repos as may be permitted by RBI. A part of the net assets may be invested in the Collateralised Borrowing & Lending Obligations (CBLO) or repo or in an alternative investment as may be provided by RBI to meet the liquidity requirements.

No investments shall be made in securitised debt, debt derivative instruments and foreign debt securities.

The Scheme shall not engage in Stock Lending.

Pending deployment of funds of the Scheme in securities in terms of the investment objective, the AMC may park the funds of the Scheme in short term deposits of scheduled commercial banks, subject to the guidelines issued by SEBI vide its circular dated April 16, 2007, as amended from time to time.

The initial investment shall be entirely in fixed income securities. The Scheme shall not invest in equity instruments at any point of time during the tenure of the Scheme.

Change in Asset Allocation Pattern

Subject to SEBI (MF) Regulations, the asset allocation pattern indicated above may change from time to time, keeping in view market conditions, market opportunities, applicable regulations and political and economic factors. It must be clearly understood that the percentages stated above are only indicative and not absolute. These proportions may vary substantially depending upon the perception of the AMC, the intention being at all times to seek to protect the interests of the Unit holders. Such changes in the investment pattern will be for short term and only for defensive considerations.

In the event of the asset allocation falling outside the limits specified in the asset allocation table, the Fund Manager will endeavour to review and rebalance the same within 90 days.

"AAA (so)" Rating is being assigned by CRISIL and is valid only for HDFC Debt Fund for Cancer Cure. The rating only indicates highest degree of certainty regarding payment of face value of

investment (excluding entry load charged, if any) to the unit holders on maturity and is not an opinion on the stability of the scheme's NAV before its maturity date. The rating will be reviewed on a quarterly basis.

Debt Market In India

The instruments available in Indian Debt Market are classified into two categories, namely Government and Non - Government debt. The following instruments are available in these categories:

 - Certificates of Deposit
 - Promissory Notes
 - Bonds
 - Fixed Coupon Bonds
 - Floating Rate Bonds
 - Zero Coupon Bonds
- Instruments issued by Corporate Bodies
 - Commercial Paper
 - Non-Convertible Debentures
 - Fixed Coupon Debentures
 - Floating Rate Debentures
 - Zero Coupon Debentures

Activity in the Primary and Secondary Market is dominated by Central Government Securities including Treasury Bills. These instruments comprise close to 50% of all outstanding debt and close to 75% of the daily trading volume on the Wholesale Debt Market Segment of the National Stock Exchange of India Limited.

In the money market, activity levels of the Government and Non-Government Debt vary from time to time. Instruments that comprise a major portion of money market activity include,

- Overnight Call
- Collateralised Borrowing & Lending Obligations (CBLO)
- Treasury Bills
- Government Securities with a residual maturity of < 1 year
- Commercial Paper
- Certificates of Deposit

Apart from these, there are some other options available for short tenure investments that include MIBOR linked debentures with periodic exit options and other such instruments. Though not strictly classified as Money Market Instruments, PSU / DFI / Corporate paper with a residual maturity of < 1 year, are actively traded and offer a viable investment option.

The following table gives approximate yields prevailing during the month of December 2010 on some of the instruments. These yields are indicative and do not indicate yields that may be obtained in future as interest rates keep changing consequent to changes in macro economic conditions and RBI policy.

Generally, for instruments issued by a non-Government entity (corporate / PSU bonds), the yield is higher than the yield on a Government Security with corresponding maturity. The difference, known as credit spread, depends on the credit rating of the entity.

D. WHERE WILL THE SCHEME INVEST?

The corpus of the Scheme shall be invested in any (but not exclusively) of the following securities:

- Debt securities:

The Scheme will retain the flexibility to invest in the entire range of debt instruments and money market instruments. These instruments are more specifically highlighted below:

- Debt instruments (in the form of non-convertible debentures, bonds, secured premium notes, zero interest bonds, deep discount bonds, floating rate bond / notes, securitised debt, pass through certificates, asset backed securities, mortgage backed securities and any other domestic fixed income securities including structured obligations etc.) include, but are not limited to:

- Debt obligations of the Government of India, State and local Governments, Government Agencies and statutory bodies (which may or may not carry a state / central government guarantee),
- Securities that have been guaranteed by Government of India and State Governments,
- Securities issued by Corporate Entities (Public / Private sector undertakings),
- Securities issued by Public / Private sector banks and development financial institutions.

- Money Market Instruments include:

- Commercial papers
- Commercial bills
- Treasury bills
- Government securities having an unexpired maturity upto one year
- Collateralised Borrowing & Lending Obligation (CBLO)
- Certificate of deposit
- Usance bills
- Permitted securities under a repo / reverse repo agreement
- Any other like instruments as may be permitted by RBI / SEBI from time to time

The scheme will invest in a portfolio predominantly of highly rated securities that are generally maturing in line with the duration of the scheme (3 years).

Investments in Debt securities and Money Market Instruments will be as per the limits specified in the asset allocation table as mentioned on Page No. 15, subject to permissible limits laid under SEBI (MF) Regulations.

Investments in debt will be made through secondary market purchases, initial public offers, other public offers, placements and right offers (including renunciation).

- Pending deployment as per investment objective, the moneys under the Scheme may be parked in short-term deposits of Scheduled Commercial Banks.

The Scheme shall abide by the following guidelines for parking of funds in short term deposits:

- "Short Term" for parking of funds shall be treated as a period not exceeding 91 days.
- Such short-term deposits shall be held in the name of the Scheme.
- The Scheme shall not park more than 15% of the net assets in short term deposit(s) of all the scheduled commercial banks put together. However, such limit may be raised to 20% with prior approval of the Trustee.
- Parking of funds in short term deposits of associate and sponsor scheduled commercial banks together shall not exceed 20% of total deployment by the Mutual Fund in short term deposits.
- The Scheme shall not park more than 10% of the net assets in short term deposit(s), with any one scheduled commercial bank including its subsidiaries.
- The Scheme shall not park funds in short-term deposit of a bank, which has invested in the Scheme.

The aforesaid limits shall not be applicable to term deposits placed as margins for trading in cash and derivatives market.

- The Scheme may invest in other schemes managed by the AMC or in the schemes of any other mutual funds, provided it is in conformity with the investment objectives of the Scheme and in terms of the prevailing SEBI (MF) Regulations. As per the SEBI (MF) Regulations, no investment management fees will be charged for such investments and the aggregate inter scheme investment made by all the schemes of HDFC Mutual Fund or in the schemes of other mutual funds shall not exceed 5% of the net asset value of the HDFC Mutual Fund.

The proceeds collected during the NFO shall be used only on or after the closure of the NFO period.

E. WHAT ARE THE INVESTMENT STRATEGIES? INVESTMENT STRATEGY AND RISK CONTROL

The net assets of the Scheme will be predominantly invested in highly rated fixed income securities like Debt, Money market instruments and Government Securities maturing on or before the maturity date of the Scheme. The primary objective of the Scheme is to endeavor to protect the capital and generate income through investments in high quality fixed income securities like Debt / Money Market Instruments and Government Securities maturing on or before the maturity date of the Scheme.

The scheme will endeavor to achieve stability of capital (with an intent to protect capital) and generate reasonable return by building a portfolio that is a judicious mix of safe debt, money market instruments and government securities maturing on or before the maturity date of the Scheme.

In view of the above, deployment of the proceeds collected during the NFO shall be made as under:

- (a) To begin with the Fund Manager shall invest the entire NFO proceeds in the Money Market instruments and Bank Fixed Deposits in accordance with the Asset Allocation Pattern of the Scheme till the time appropriate Debt Instruments and Government Securities maturing on or before the maturity date of the Scheme are available.
- (b) In line with the Investment Objective of the Scheme, the fund manager shall construct the portfolio by investing in the Debt instruments and Government Securities maturing on or before the maturity date of the Scheme.
- (c) Coupons accrued, if any may be deployed in Debt instruments, Money Market instruments or Government Securities maturing on or before the maturity date of the Scheme.
- (d) The Fund Manager may look to increase the maturity of the portfolio by removing some shorter maturity Debt instruments and investing in Debt instruments which are maturing closer to the maturity of the Scheme.

The maturity proceeds (i.e. principle + coupon accrued) of the Debt instruments that mature before the maturity of scheme shall be re-invested in the Debt instruments, Money Market instruments or Government Securities until the maturity of the Scheme.

The asset allocation pattern described above would alter from time to time on keeping in view market conditions, market opportunities, applicable regulations and political, economic factors and review by rating agency.

The scheme is "oriented towards protection of capital" and "not with guaranteed returns". The scheme does not guarantee any returns. The orientation towards protection of capital originates from the structure of the Portfolio of the Scheme and not from any Bank guarantee, Insurance Cover etc. There is no assurance that the structure would provide the necessary protection of capital.

Though every endeavor will be made to achieve the objectives of the Scheme, the AMC/Sponsors/Trustees do not guarantee that the investment objectives of the Scheme will be achieved. No guaranteed returns are being offered under the Scheme.

RISK CONTROL

Investments made from the corpus of the Scheme would be in accordance with the investment objective of the Scheme and the provisions of the SEBI (MF) Regulations. The AMC will strive to achieve the investment objective by way of a judicious portfolio mix comprising of debt, money market instruments and government securities. Every investment opportunity would be assessed with regard to credit risk, interest rate risk and liquidity risk.

Credit Risk

A detailed credit evaluation of each investment opportunity will be undertaken. The AMC will utilise ratings of recognised rating agencies as an input in the decision making process. Investments in bonds and debentures will usually be in instruments that have been assigned high investment grade ratings by a recognized rating agency. The AMC Board and the Trustee shall approve the detailed parameters for such investments. The details of such investments would be communicated by the AMC to the Trustee in their periodical reports. It would also be clearly mentioned in the reports, how the parameters have been complied with. However, in case any security does not fall under the parameters, the prior approval of Board of AMC and Trustee shall be sought.

Interest Rate Risk

An interest rate scenario analysis would be performed on an on-going basis, considering the impact of the developments on the macro-economic front and the demand and supply of funds. Based on the above analysis, the AMC would manage the investments of the Scheme on a dynamic basis to exploit emerging opportunities in the investment universe and manage risks at all points in time.

Liquidity Risk

The AMC will provide liquidity by maintaining a low average duration of the portfolio and by investing in securities that would result in a staggered maturity profile of the portfolio. Liquidity will also be managed by investing in the Collateralised Borrowing & Lending Obligations (CBLO) / repo market when CBLO money / repo yields are attractive relative to other money market yields. Investment in debt instruments would generally be in securities that have reasonable secondary market activity.

Due to the short duration of the portfolio and the low risk product profile, the effect of volatility in debt markets on the portfolio will be limited. This permits investors to enhance their yields without compromising on the quality of the portfolio.

In the event of a requirement to liquidate all or a substantial part of these investments in a very short duration of time, the AMC may not be able to realize the full value of these securities leading to an adverse impact on the Net Assets of the Scheme. Please refer to "**Suspension of Sale / Redemption of the Units**", in section '**Restrictions, if any, on the right to freely retain or dispose of units being offered**' on **Page No. 28**.

PORTFOLIO TURNOVER

Investors can subscribe (purchase) / redeem (sell) Units on a continuous basis on the National Stock Exchange of India Ltd. on which the Units are listed during the trading hours like any other publicly traded stock. In view of the nature of the Scheme, there will likely be no turnover in the portfolio (except for change in composition of portfolio of securities made as per the prevailing market conditions) of the Scheme.

INVESTMENT DECISIONS

The Investment Committee, comprising of the Managing Director, the Chief Investment Officer, Fund Manager(s) - Equities (for authorising equity transactions only), Senior Fund Manager (Fixed Income) & Head of Credit (for authorising fixed income transactions only), Senior Fund Manager - Fixed Income (for authorising fixed income transactions only), Company Secretary and the Chief Compliance Officer, will decide on the investment proposals (quorum of any two disinterested members). The investment proposals precede each investment decision and are reviewed by members of the Investment Committee. The initial investment proposals *inter-alia* will contain details like company and management background, business outlook, financial analysis / valuation and reasons for recommendation, as necessary. Subsequent proposals *inter-alia* will contain key investment characteristics, valuation and reasons for recommendation. Periodic presentations will be made to the Board of Directors of the AMC and Trustee Company to review the performance of the Scheme.

All investment decisions shall be recorded in terms of SEBI Circular No. MFD/CIR/6/73/2000, dated July 27, 2000 as amended from time to time.

The Managing Director of the AMC shall *inter-alia* ensure that the investments made by the fund managers are in the interest of the Unit holders. The Fund Manager shall ensure that the funds of the Scheme are invested in line with the investment objective of the Scheme and in the interest of the Unit holders.

INVESTMENT BY THE AMC IN THE SCHEME

The AMC may invest in the Scheme during the New Fund Offer Period subject to the SEBI (MF) Regulations. The AMC may also invest in existing schemes of the Mutual Fund. As per the existing SEBI (MF) Regulations, the AMC will not charge Investment Management and Advisory fee on the investment made by it in the respective Scheme or existing Schemes of the Mutual Fund.

I. WHAT ARE THE INVESTMENT RESTRICTIONS?

Pursuant to SEBI (MF) Regulations, the following investment restrictions are applicable to the Scheme:

- The Mutual Fund shall buy and sell securities on the basis of deliveries and shall in all cases of purchases, take delivery of relevant securities and in all cases of sale, deliver the securities:

Provided further that sale of government security already contracted for purchase shall be permitted in accordance with the guidelines issued by the Reserve Bank of India in this regard.
- The Mutual Fund shall enter into transactions relating to Government Securities only in dematerialised form.

Changes in Fundamental Attributes

In accordance with Regulation 18 (15A) of the SEBI (MF) Regulations, the Trustee shall ensure that no change in the fundamental attributes of the Scheme and Option thereunder or the trust or fee and expenses payable or any other change which would modify the Scheme and the Option thereunder and affect the interest of Unit holders is carried out unless:

- A written communication about the proposed change is sent to each Unit holder and an advertisement is given in one English daily newspaper having nationwide circulation as well as in a newspaper published in the language of the region where the Head Office of the Mutual Fund is situated; and
- The Unit holders are given an option for a period of 30 days to exit at the prevailing Net Asset Value without any Exit Load.

G. HOW WILL THE SCHEME BENCHMARK ITS PERFORMANCE?

BENCHMARK INDEX

The Benchmark Index for the Scheme would be Crisil Short Term Bond Fund Index. The Scheme intends to have a portfolio mix of instruments, which are mainly captured by Crisil Short Term Bond Fund Index. Hence, it is an appropriate benchmark for the Scheme.

The Trustee reserves the right to change the benchmark for evaluation of performance of the Scheme from time to time in conformity with the investment objectives and appropriateness of the benchmark subject to SEBI (MF) Regulations, and other prevailing guidelines, if any.

- The Mutual Fund will, for securities purchased in the non-depository mode get the securities transferred in the name of the Mutual Fund on account of the Scheme, wherever the investments are intended to be of a long term nature.

- The Scheme shall not invest more than 15% of its NAV in debt instruments [irrespective of residual maturity period (above or below one year)], issued by a single issuer, which are rated not below investment grade by a credit rating agency authorised to carry out such activity under the SEBI Act. Such investment limit may be extended to 20% of the NAV of the Scheme with the prior approval of the Trustee and the Board of the AMC.

Provided that such limit shall not be applicable for investments in government securities.

- The Scheme shall not invest more than 30% of its net assets in money market instruments of an issuer.

Provided that such limit shall not be applicable for investments in Government securities, treasury bills and collateralized borrowing and lending obligations.

- Transfer of investments from one scheme to another scheme in the same Mutual Fund, shall be allowed only if:-
 - (a) such transfers are made at the prevailing market price for quoted Securities on spot basis
Explanation : spot basis shall have the same meaning as specified by Stock Exchange for spot transactions
 - (b) the securities so transferred shall be in conformity with the investment objective of the scheme to which such transfer has been made.
- The Scheme may invest in another scheme under the same AMC or any other mutual fund without charging any fees, provided that aggregate inter-scheme investment made by all schemes under the same AMC or in schemes under the management of any other asset management shall not exceed 5% of the net asset value of the Mutual Fund.
- Pending deployment of funds as per investment objective, the moneys under the Scheme may be parked in short-term deposits of Scheduled Commercial Banks. The Scheme shall abide by the guidelines for parking of funds in short term deposits as mentioned in section 'WHERE WILL THE SCHEME INVEST?' on Page No. 16.
- The Scheme shall not make any investments in:
 - (a) any unlisted security of an associate or group company of the Sponsors; or
 - (b) any security issued by way of private placement by an associate or group company of the Sponsors; or
 - (c) the listed securities of group companies of the Sponsors which is in excess of 25% of the net assets.
 - (d) any fund of funds scheme
- The Scheme shall invest only in such securities which mature on or before the date of its maturity in accordance to SEBI Circular No. SEBI/IMD/CIR No. 12/147132/08 dated December 11, 2008.

In addition to the above Regulatory restrictions, the scheme would follow the following norms:

- The fixed income component of the Scheme shall be invested only in Government of India Securities (GSecs) and/or other fixed income instruments rated AAA/AAA (so) by CRISIL or its equivalent.
- Prior approval shall be obtained from CRISIL before investing in any non-CRISIL rated fixed income security.
- The AMC shall provide adequate information on such companies that are not rated by CRISIL to enable CRISIL to take a view on the credit quality of the instrument. If any fixed income security gets downgraded during the tenure of the Scheme, the AMC will ensure that the credit quality of the fixed income portfolio should be equivalent to AAAf (the rating definition of AAAf is as follows - The fund's portfolio holdings provide very strong protection against losses from credit defaults). If otherwise CRISIL will analyze the protection available from the debt holdings of the Scheme at that time, to decide whether the rating of AAA(so)

on the capital protected fund can be maintained.

- The Scheme shall not invest in securitized debt instruments.
- No securities lending transactions would be engaged in.
- While selecting the fixed income securities for the debt component, the Scheme shall as far as possible invest in securities with maturity (or a Put Option with the investor) within 30 days prior to the date of the Scheme's redemption.
- In no circumstances the Scheme shall invest in fixed income securities with final maturities beyond the Scheme's Redemption Date, unless there is a Put Option available on the instrument to the investor to ask for repayment on or before the Scheme's Maturity Date. Further, the Scheme shall invest in instruments with early Put Option provided that the principal amount to be received on the exercise of the Put Option is clearly known at the time of the investment in the instrument. The value that will be realized on the exercise of the Put Option will only be considered as part of the debt component at the time of calculating the minimum debt component. In addition, if an investment is made in an instrument with early Put Option but the final contractual maturity is beyond the Scheme's Maturity Date, then Put Option shall be compulsorily exercised on the Put Option date before the Scheme Maturity Date.
- While selecting fixed income securities for the debt portfolio, as far as possible, the Scheme shall invest in securities with a one time bullet payments of principal at maturity to minimize reinvestment risks.
- The Scheme shall not invest in securities with early Call Options.
- The Scheme shall follow a passive investment strategy for the fixed income component of the Scheme.
- Active trading in debt instruments can be done only if the additional yield on the new instruments, with the same residual tenor as the original instrument, more than compensates for the impact cost incurred on selling the original security.
- The Scheme shall ensure that all transactions which are complete upon delivery shall be carried out on a delivery against payment basis. For all other transactions the Scheme shall transact with counterparties that are rated AA- and above/P1+ by CRISIL.
- All investments in debt instruments shall be in compliance with the regulations with respect to concentration limits prevailing at the time of the portfolio construction.

The AMC may alter these above stated restrictions from time to time to the extent the SEBI (MF) Regulations change, so as to permit the Scheme to make its investments in the full spectrum of permitted investments for mutual funds to achieve its respective investment objective. The Trustee may from time to time alter these restrictions in conformity with the SEBI (MF) Regulations.

The proceeds collected during the NFO shall be used only on or after the closure of the NFO period.

All investment restrictions shall be applicable at the time of making investment.

Further, based on the list provided by the Depositories (NSDL/ CDSL) giving the details of the demat account holders and the number of Units held by them in electronic form on the Record date fixed for redemption of Units on the Maturity date / Final Redemption date, the Registrars & Transfer Agent will pay the redemption proceeds by forwarding a cheque or directly crediting the bank account linked to the demat account depending on the mode of receipt of redemption proceeds chosen by the Unit holder.

REDEMPTION BY NRIs / FIIs

Credit balances in the account of an NRI / FII Unit holder, may be redeemed by such Unit holder in accordance with the procedure described in SID and subject to any procedures laid down by the RBI, if any.

Payment to NRI / FII Unit holders will be subject to the relevant laws / guidelines of the RBI as are applicable from time to time (also subject to deduction of tax at source as applicable).

In the case of NRIs

- (i) Credited to the NRI Investor's NRO account, where the payment for the purchase of the Units redeemed was made out of funds held in NRO account or
- (ii) Remitted abroad or at the NRI Investor's option, credited to his NRE / FCNR / NRO account, where the Units were purchased on repatriation basis and the payment for the purchase of Units redeemed was made by inward remittance through normal banking channels or out of funds held in NRE / FCNR account.

In the case of FIIs

Credit the net amount of redemption proceeds of such Units to the foreign currency account or Non-Resident Rupee Account of the FII Investor.

Pursuant to Government of India Notification No. GSR (381) E dated May 3, 2000, transactions which are not specifically prohibited under the Foreign Exchange Management (Current Account Transactions) Rules, 2000 or which are not included in Schedule II (transactions specified in this Schedule require prior approval of the Government of India) or Schedule III (transactions specified in this Schedule require prior approval of Reserve Bank of India) may be permitted by authorized dealers without any monetary / percentage ceilings subject to compliance with the provisions of Section 10(5) of the Foreign Exchange Management Act, 1999.

BANK DETAILS

For Investors holding units in demat mode, the procedure for change in bank details would be as determined by the depository participant.

For Investors holding units in non-demat mode, the procedure as detailed below shall be applicable. In order to protect the interest of Unit holders from fraudulent encashment of redemption / dividend cheques, SEBI has made it mandatory for Investors to provide their bank details viz. name of bank, branch, address, account type and number, etc. to the Mutual Fund. **Applications without complete bank details shall be rejected.** The AMC will not be responsible for any loss arising

out of fraudulent encashment of cheques / warrants and / or any delay / loss in transit.

Unit holders are free to change their bank details registered with the Mutual Fund subject to adherence with the following procedure:

1. Unit holders will be required to submit a valid request for a change in bank account details along with a cancelled original cheque leaf of the new bank account as well as the bank account currently registered with the Mutual Fund (where the account number and first unit holder name is printed on the face of the cheque). Unit holders should without fail cancel the cheque and write 'Cancelled' on the face of it to prevent any possible misuse.
2. Where such name is not printed on the original cheque, the Unit holder may submit a letter from the bank on its letterhead certifying that the Unit holder maintains/maintained an account with the bank, the bank account information like bank account number, bank branch, account type, the MICR code of the branch & IFSC Code (where available).
3. In case of non-availability of any of these documents, a copy of the bank pass book or a statement of bank account having the name and address of the account holder and account number.

(In respect of (2) and (3) above, they should be certified by the bank manager with his / her full signature, name, employee code, bank seal and contact number)

4. Unit holders may also bring a copy of any of the documents mentioned in (3) above along with the original documents to the ISCs/Official Points of Acceptance of HDFC Mutual Fund. The copy of such documents will be verified with the original documents to the satisfaction of HDFC Mutual Fund. The originals documents will be returned across the counter to the Unit holder after due verification.

In the event of a request for change in bank account information being invalid / incomplete / not satisfactory in respect of signature mismatch/document insufficiency/ not meeting any requirements more specifically as indicated in clauses 1-4 above, the request for such change will not be processed. Redemptions / dividend payments, if any, will be processed and the last registered bank account information will be used for such payments to Unit holders. Unit holders may note that it is desirable to submit their requests for change in bank details atleast 7 days prior to date of redemption / dividend payment, if any. Further, in the event of a request for redemption of units being received within seven days of a request for change in bank account details, the normal processing time as specified in the Scheme Information Document, may not necessarily apply, however it shall be within the regulatory limits.

Unit holders are advised to provide their contact details like telephone numbers, mobile numbers and email IDs to HDFC Mutual Fund in writing.

The Trustee reserves the right to amend the aforesaid requirements.

Payment to Alternate Payee

The Mutual Fund may subject to compliance with such requirement as it deems fit and necessary may stipulate, arrange to issue redemption and / or any distribution cheques in favour of an alternate payee on Unit holder(s) specific request either at the time of investment and /or at the time of redemption or any distribution. Reasonable procedures will need to be followed to assure that instructions from Unit holders regarding payment

	to Alternate Payee are genuine. The Unit holder(s) would be liable for the loss resulting from a fraudulent encashment / payment to Alternate Payee, based on the Unit holders instructions, that the Mutual Fund reasonably believed as genuine. The Mutual Fund, reserves the right to require an indemnity or verification countersigned by a Bank Manager, Notary Public, Magistrate or any other party acceptable to it before accepting such instructions. All payments and settlements made to such Alternate Payee(s) and a receipt thereof shall be a valid discharge by the Mutual Fund and the Mutual Fund shall not in any manner liable to the Unit holder. It may be noted that there is no commitment from the Mutual Fund that this facility will be available to the Unit holders.

D. COMPUTATION OF NAV

The Net Asset Value (NAV) per Unit of the Scheme will be computed by dividing the net assets of the Scheme by the number of Units outstanding under the Scheme on the valuation date. The Mutual Fund will value its investments according to the valuation norms, as specified in Schedule VIII of the SEBI (MF) Regulations, or such norms as may be specified by SEBI from time to time.

NAV of Units under the Scheme shall be calculated as shown below:

E. ELIGIBILITY FOR CLAIMING DEDUCTION UNDER SECTION 80G OF INCOME-TAX ACT, 1961

There are various Tax Deductions or Tax Exemptions provided under the Indian Income- tax Act, 1961. The tax deductions help to deduct an amount from the taxable income and thereby help to save tax.

Through such deductions and consequent income tax benefit, Income- tax Act encourages many good causes - like buying a house, getting higher education, supporting a disabled dependent, etc.

One good cause that it also encourages is donation to charities or donations made for public good. This is covered under section 80G of the Income- tax Act, 1961.

Income Tax deduction - Section 80G

It is Section 80G of the Income- tax Act, 1961 that permits to the donors to the Societies and Trusts registered under the Act, the benefits of income tax deduction on their donation. This is one of the incentives provided for the people to donate for a noble cause.

Accordingly, Indian Cancer Society (ICS) is registered as a Public Charitable Trust under the Income- tax Act, 1961 under Section 12A (Registration No.BMY/INS/I(a)/16/74-75) and under Section 80G vide order No. DIT(E)/MC/80G/1500/2008/2008-09) dated 26.03.2009 issued by the Office of the Director of Income Tax (Exemption), Mumbai for the period April 1, 2009 to March 31, 2012. In view of this, fifty percent of donations made to ICS will be entitled to be deducted from the taxable income of the donor (subject to fulfillment of certain conditions).

Financial aid for cancer treatment and care is the most critical need of the underprivileged section of the society, which ICS aims to fulfill in a substantial way by associating with HDFC Mutual Fund. 'HDFC Debt Fund for Cancer Cure' will be the enabling vehicle for this purpose. Donation of part or the whole of the dividend income made by the Investors (i.e. Donor) of 'HDFC Debt Fund for Cancer Cure' would then be utilized by ICS for the following societal purposes:

- Fund the medical treatment costs of needy and under-privileged cancer patients in established hospitals
- Provide medically recommended food and nutritional support to the cancer patients undergoing treatment.
- Meet direct expenses of carrying out the above activities through social workers and other support staff, limited to 5% of the total donations.

Income tax benefits u/s 80G on their donations out of the dividend income shall be an added incentive for these investors to donate for such a noble cause. **Your donation can make a difference in the ICS's fight against cancer-in your own community and across the country.**

Section 80G deduction is available to any tax payer (may be individual, company, firm or any other taxable entity) making donation to ICS.

Methodology:

For computing the taxable income of the tax payer and for arriving at the deductible amount under section 80G, first the aggregate of certain specified sums donated to various organizations eligible under section 80G (including the donation made out of the dividend income from the investments made in the HDFC Debt Fund for Cancer Cure) will be computed. Thereafter the gross total income as reduced by certain other permissible deductions will be determined (i.e the adjusted gross total income). If the aggregate donations are more than 10 per cent of the adjusted gross total income, the excess over 10% will have to be ignored. Thereafter, 50 per cent of the resultant figure will be allowed to be deducted from the gross total income for arriving at the taxable income.

(vi)	Lower of (iv) and (v)	₹ 60,000
(vii)	Amount of deduction available u/s 80G [50% of (vi)]	₹ 30,000

At the maximum marginal tax rate of 30.9%, you would then save 30.9% of ₹ 30,000 i.e. ₹ 9,270 of income tax.

Issuance of certificate

A copy of the certificate under Section 80G issued by the Income Tax Department to ICS will be issued to the Unit holder making the donation alongwith the receipt for such donation to enable them to claim the deduction for Income Tax purposes.

Please note that your donation will come out of the dividend income from the investment made by you in the HDFC Debt Fund for Cancer Cure. For this purpose, once the Investor opts for 50% Dividend Donation Option or 100% Dividend Donation Option, the same can not be changed/ modified thereafter by the Investor and the amount once donated to ICS upon such authorization will not be refunded back to the Investor upon such request.

The donors are most welcome to re-assure themselves that their donations have been used for the purpose they have specified. All the donations made under the Scheme will be credited to an exclusive bank account of ICS dedicated to cancer treatment. IV. FEES AND EXPENSES

This section outlines the expenses that will be charged to the Scheme. A. NEW FUND OFFER (NFO) EXPENSES

These expenses are incurred for the purpose of various activities related to the NFO like marketing and advertising, registrar expenses, printing and stationary, bank charges etc.

The New Fund Offer (NFO) Expenses shall be borne by the AMC / the Trustee Company.

B. ANNUAL SCHEME RECURRING EXPENSES

C. LOAD STRUCTURE

Load is an amount, which is paid by the Investor to subscribe to the units or to redeem the units from the scheme / plans. This amount is used by the AMC to pay commissions to the distributor and to take care of other marketing and selling expenses. Load amounts are variable and are subject to change from time to time. Aggrieved by the impugned order passed by the Hon'ble High Court, HDFC filed a Special Leave Petition (SLP) before the Hon'ble Supreme Court of India, pursuant to which the Hon'ble Supreme Court of India was pleased to issue notice to SEBI in the matter. The matter is now pending before the Hon'ble Supreme Court of India. At a hearing held on April 21, 2005 the Hon'ble Supreme Court of India was pleased to admit the said SLP.

3. SEBI states in its order that Mr. Nilesh Kapadia has violated Regulations 3(a) to 3(d) and Regulation 4(1) of the SEBI (Prohibition of Fraudulent and Unfair Trade Practices Relating to Securities Market) Regulations, 2003. In the said order, it has been directed that HDFC Asset Management Company Limited and Mr. Nilesh Kapadia will jointly deposit ₹ 238.40211 lakhs, estimated loss with the Trustees i.e. HDFC Trustee Company Limited.

4. Any pending material civil or criminal litigation incidental to the business of the Mutual Fund to which the Sponsor(s) and/ or the AMC and/ or the Board of Trustees /Trustee Company and/ or any of the directors and/ or key personnel are a party.
